Sara Tina is a PhD Candidate in Civil Law at Università Cattolica del Sacro Cuore (XXXVIII Cycle). Her PhD thesis aims at evaluating the legal issues and concerns arising in the context of the sharing economy, both from Contract and Tort law perspective and through a constant interaction between problematic thinking (oriented towards identifying needs and problems underlying legal issues) and systematic thinking (oriented towards reasoning on the basis of the system, i.e. grasping the connections and possible integrations of solutions within the overall framework of the legal system). She is also involved in the study of energy communities. Her research is based on (i) an interdisciplinary approach, including the study of the economic and social impact of the sharing economy, and (ii) a comparative method, given the worldwide spread of such a phenomenon. For this reason, she is now a Visiting Researcher at Boston University to further explore the US contributions to the topic.
